

**Public Hearing**  
**Ohio Environmental Protection Agency**  
**Five-Year Rule Review of Ohio Administrative Code (OAC)**  
**Rule 3750-30-25, Identification of Hazardous Chemicals.**

Notice is hereby given that that on behalf of the State Emergency Response Commission (SERC), the Ohio Environmental Protection Agency, Division of Air Pollution Control (DAPC) has performed a review of the above referenced rule primarily to satisfy the requirements of Section 106.03 and 106.031 of the Ohio Revised Code (five-year review). The DAPC finds this rule to be necessary and with need for changes.

DAPC is proposing these changes due to USEPA recently amended its hazardous chemical reporting regulations to conform to the revisions of OSHA's Hazard Communication Standard due to its adoption of the Global Harmonizing System (GHS) classification and labeling of chemicals. USEPA reduced the existing five hazard categories to two hazard categories and added four hazards that were not specifically addressed (simple asphyxiant, combustible dust, pyrophoric gas and hazard not otherwise classified).

Pursuant to Section 121.39 of the Ohio Revised Code, DAPC was required to consult with interested parties affected by the rules before the Division formally adopts them. On May 31, 2017, these rules went out for a 30-day review by interested parties. No comments were received.

Pursuant to Section 106.03 and 106.031 of the Ohio Revised Code, a public hearing on these rule changes will be conducted on **Thursday, November 2, 2017 at 10:30 AM** at Ohio EPA, Lazarus Government Center, 50 W. Town Street, Suite 700, Columbus, Ohio. All visitors to Ohio EPA must register at the Security desk in the lobby upon arrival. Please bring photo identification (such as a valid driver's license). For security reasons, visitors are required to wear their badge at all times while in the building. Please arrive early to complete these procedures.

All interested persons are entitled to attend or be represented at the hearing and give written or oral comments on these rule changes. All oral comments presented at the hearing, and all written statements submitted at the hearing or by the close of business on November 2, 2017 will be considered by Ohio EPA prior to final action on this rule. Written statements submitted after November 2, 2017 may be considered as time and circumstances permit, but will not be part of the official record of the hearing.
