### Algal Toxin Kits

Test kits are available for both semi-quantitative and quantitative analysis of microcystin, saxitoxin, and cylindrospermopsin. Kit types range from simple test strips and tubes that can be used in the field to more rigorous analytical methods for lab-based testing. All kits are based on the Enzyme-Linked Immunosorbent Assay (ELISA) testing method. ELISA microcystin methods should be ADDA-specific. Ohio EPA is only aware of one manufacturer of microcystin-ADDA kit:

A kit is also available for the detection of anatoxin-a using a receptor-binding assay. ELISA kits for saxitoxin and cylindrospermopsin are available from several other manufacturers.
