ORC Section 3734.02(G) Exemption – Decline to Grant**

Dear Mr. Danis:

On March 9, 2010, the Ohio Environmental Protection Agency (Ohio EPA), Southwest District Office (SWDO), Division of Solid and Infectious Waste Management (DSIWM) received your exemption request titled Exemption Request Annual Leachate Cleanout Inspection, for the Tremont Landfill, Clark County, Ohio pursuant to Ohio Administrative Code (OAC) Rule 3745-27-03(B) seeking relief from the requirements of OAC Rule 3745-27-19(M)(4). OAC Rule 3745-27-19(M)(4) requires the owner or operator to submit verification that the leachate management system is operating in accordance with this rule as part of the annual report. This request was submitted by Civil & Environmental Consultants, Inc. (CEC, Inc.) on behalf of the Tremont Landfill Company, owner/operator of the Tremont Landfill (Facility), located in Clark County.

In accordance with OAC Rule 3745-27-03(B), pursuant to ORC Section 3734.02(G), the director may, by order, exempt any person generating, collecting, storing, treating, disposing of, or transporting solid wastes, including scrap tires, from any requirement of ORC Chapter 3734 or any rules adopted thereunder if granting the exemption is unlikely to adversely affect the public health or safety or the environment.


