Pursuant to Chapter 6109. and section 119.09 of the Ohio Revised Code, and the rules of the Ohio Environmental Protection Agency, the Director hereby makes the following Findings and issues the following Order:

FINDINGS

1. Prior to May 31, 2000, Jeff Ulery ("the Applicant") submitted an application for renewal of the license to operate a public water system at the Clearview Mobile Home Park (PWS ID: No. 1201312).
2. On May 31, 2000, the Director of Environmental Protection ("the Director") issued a proposed order to deny such application.
3. The Applicant filed a timely request for an adjudication hearing on the May 31, 2000 proposed order.
4. No adjudication hearing has been held in this matter.
5. During a telephone conference with the Hearing Examiner assigned to his case, counsel for both parties stated that all disputed issues in this matter had been resolved and that an adjudication hearing was no longer necessary.
6. The Hearing Examiner has filed a Report and Recommendation that this case be dismissed.
7. No objections to the Hearing Examiner's Report and Recommendation have been

Notice is hereby given that the Director of the Ohio Environmental Protection Agency, pursuant to Chapter 6109., sections 119.09 et seq. of the Ohio Revised Code, and the rules of the Ohio Environmental Protection Agency, has issued Final Findings and Orders to dismiss Jeff Ulery's appeal of the proposed order to deny the license to operate application for the year 2000 for Clearview Mobile Home Park.
