Dear Mr. Wilcox:

On August 30, 2001, Floyd Browne Associates, Inc., acting on behalf of the Village of Ansonia, submitted an explosive gas monitoring plan for the closed Village of Ansonia Landfill located in Darke County. The explosive gas monitoring plan was submitted pursuant to Ohio Administrative Code (OAC) Rule 3745-27-12. Final revisions to the plan were submitted on January 4, 2002.

Ohio EPA has reviewed the plan, and we have determined that it is in substantial compliance with OAC Rule 3745-27-12. Therefore, I hereby approve the explosive gas monitoring plan.

Issuance of this approval does not constitute expressed or implied agreement that the monitoring of the facility, if performed and implemented in accordance with the approved explosive gas monitoring plan and/or its terms and conditions, will constitute compliance with all applicable state and federal laws, rules, and regulations.

You are hereby notified that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. It must be filed with the commission within 30 days after notice of the director's action. A copy of the appeal must be served on the director within three days of filing with the commission. An appeal may be filed with the commission at the following address:
