The Ohio Environmental Protection Agency (Ohio EPA) completed its review of the Corrective Measures Plan (CMP) dated July 17, 2001, and the CMP revisions dated February 28, 2002; March 1, 2002; and May 3, 2002, for the Owens Corning Landfill, located in Licking County. These documents were prepared and submitted in accordance with Ohio Administrative Code (OAC) Rule 3745-29-10(F). Ohio EPA has determined that the CMP fulfills the requirements of OAC Rule 3745-29-10(F). The selected corrective measure, Alternative #2, which proposes corrective measures monitoring and periodic pumping of well 8911U to remove antimony combined with possible source investigation and removal, is hereby approved.

You are hereby notified that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the ground upon which the appeal is based. It must be filed with the Commission within thirty (30) days after notice of the Director's action. A copy of the appeal must be served on the Director within three (3) days of filing with the Commission. An appeal may be filed with the Commission at the following address:
