The Fairborn Landfill Explosive Gas Monitoring Plan (Plan) was submitted on February 1, 1989. A revised EGMP, meeting the requirements of Ohio Administrative Code (OAC) Rule 3745-27-12 was received on June 3, 2002. The plan consists of a two-part document titled, *Explosive Gas System Design And Landfill Gas Monitoring Plan*.

Ohio EPA hereby approves the Plan for the Fairborn Landfill and the Plan shall be immediately implemented.

Issuance of this approval does not constitute expressed or implied agreement that the monitoring of the facility, if performed and implemented in accordance with the approved explosive gas monitoring plan and/or its terms and conditions, will constitute compliance with all applicable state and federal laws, rules, and regulations.

You are hereby notified that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission (Commission) pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. It must be filed with the Commission within 30 days after notice of the director's action. A copy of the appeal must be served on the Director within three days of filing with the Commission.
