Extension of Permit Termination Date**

Dear Ms. Shahade:

The Ohio Environmental Protection Agency (Ohio EPA) issued permit to install (PTI) No. 02-12980 on February 2, 2001, to C&E Coal, Inc., to construct and operate a new scrap tire monofill facility to be located in Stark County. Construction of the facility is required to begin by August 2, 2002, in accordance with Ohio Administrative Code (OAC) Rule 3745-31-06(A).

On May 29, 2002, Ohio EPA received a request from Vorys, Sater, Seymour and Pease LLP, on behalf of Liberty Tire Services of Ohio, LLC (Liberty), stating that Liberty had purchased the scrap tire business assets of C&E Coal, Inc. thus purchasing the New Scrap Tire Monofill Facility and associated PTI No. 02-12980. Liberty is requesting a 12-month extension of the eighteen-month construction period specified in OAC Rule 3745-31-06(A) pursuant to OAC Rule 3745-31-06(C).

Ohio EPA has reviewed your request and, pursuant to OAC Rule 3745-31-06(C), hereby grants approval to extend the termination date of PTI No. 02-12980. This permit will now terminate on August 2, 2003, unless Liberty has undertaken a continuing program of installation or has entered into a binding contractual obligation to undertake and complete within a reasonable time, a continuing program of installation. This approval to extend the termination date applies only to solid waste PTI No. 02-12980 and does not extend any other permits issued for the facility..
