Dear Mr. Kappler:

On May 8, 2002, the Ohio Environmental Protection Agency (Ohio EPA), Northeast District Office (NEDO) received a letter from URS Corporation (URS), on behalf of the City of Brooklyn, requesting to decrease their financial assurance cost estimates for closure and post-closure care of the City of Brooklyn Sanitary Landfill.

Ohio EPA has reviewed the request and has determined that the City of Brooklyn is hereby authorized to decrease financial assurance cost estimates for the City of Brooklyn Sanitary Landfill in accordance with OAC Rules 3745-27-15 and 3745-27-16. As indicated by the request, the closure cost estimate may be decreased to \$4,047,581.36 and the yearly post-closure care cost estimate reduced to \$58,080.00.

You are hereby notified that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission (Commission) pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the director's action. A copy of the appeal must be served on the director within three (3) days of filing with the Commission. An appeal may be filed with the Commission at the following address:
