RE: FRANKLIN COUNTY, SOLID WASTE AUTHORITY OF CENTRAL OHIO, FRANKLIN COUNTY LANDFILL, REQUEST FOR ALTERNATE PARAMETERS LIST FOR GROUND WATER MONITORING

Dear Mr. Dodge:

On December 10, 2004, this office received a letter from the Solid Waste Authority of Central Ohio (SWACO) regarding the Alternate Parameter list approved on November 4, 2004. This letter was a follow up to the phone conversation between Mr. Eric Van Heyde of Civil & Environmental Consultants, Inc., action on behalf of SWACO, and Mr. Cal James and myself on December 6, 2004.

Upon implementation of this alternate list, two errors were found. The first error was that COD should have been deleted from both the Uppermost aquifer system as well as the significant zone of saturation. The November 4, 2004 approved list only had it being deleted from the significant zone of saturation.

The second error was total alkalinity being left on the list to be monitored in the significant zone of saturation. Total alkalinity should be deleted from the significant zone of saturation semiannual detection monitoring list. Attached is the corrected alternate parameter list for the Franklin County Landfill.

These proposed changes to the parameter list meet the requirements of the Ohio Administrative Code 3745-27-10(D)(3) and as such are approved.

You are hereby notified, that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the ground upon which the appeal is based. It must be filed with the Commission within thirty (30) days after notice of the Director's action. A copy of the appeal must be served on the Director within three (3) days of filing with the Commission.
