RE: Permit-to-Install Extension Request, Republic Services of Ohio Hauling, PTI #05-11359

Dear Mr. Beamer:

On December 30, 2004, the Ohio Environmental Protection Agency (Ohio EPA), Southwest District Office (SWDO), received your request to extend the Republic Services of Ohio Hauling (Republic) Permit-to-Install (PTI #05-11359) issued September 3, 2003. Pursuant to Condition 6 of the PTI, the permittee is required to undertake a continuing program of installation or modification, or enter into a binding contractual obligation to undertake and complete within a reasonable time a continuing program of installation or modification within 18 months after issuance. This PTI Condition also allows for a 12-month extension of the time frame.

Citing the pending expiration of the Ohio EPA Solid Waste PTI (#05-11359) for this project coupled with the relative timing of fiscal year budgets, Republic has not begun construction of the facility within the required 18-month time frame and thus, has requested a 12 month extension.

Ohio EPA has reviewed your request and pursuant to OAC 3745-27-02(l)(3), I hereby approve a 12-month extension of the termination date of PTI #05-11359. Should construction not be initiated by the applicant by March 3, 2006, this permit will terminate.

You are hereby notified that this action of the Director of Environmental Protection is final and may be appealed to the Environmental Review Appeals Commission (Commission) pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. It must be filed with the Commission within thirty days after notice of the Director's action. A copy of the appeal must be served on the Director within three days of filing with the Commission. An appeal may be filed with the Commission at the following address:
