Update for Modification to Permit #02-14796,
Order 2.B., Director's Findings and Orders of March 28, 2007
Countywide Recycling & Disposal Facility**

The purpose of this submittal is to inform Ohio EPA of the rules (OAC 3745-27-02, 06, 07, 15, 16, and 17 and any other applicable requirements) which can be satisfied by existing permit documents for the modification to permit to install #02-14796 (permit modification) as stated in Order 2.B. of the Findings and Orders issued to Countywide Recycling and Disposal (Countywide) on March 28, 2007.

In preparation of this task, Countywide engaged the services of Cornerstone Environmental Group, LLC (CEG) to review the application for permit to install #02-14796 to determine the applicability of OAC 3745-27-02, 06, 07, 15, 16, and 17 to the permit modification and determine which existing documents from the permit to install #02-14796 do not need to be updated. CEG conducted a systematic review of each respective rule paragraph for this evaluation. A summary of our determination is presented in the attached Table 1. Tables 2 through 7 present detailed results of this evaluation. Each table lists the OAC rule by paragraph, the applicability of the rule to the permit modification and if applicable, whether the existing permit documents do or do not need to be updated.
