PUBLIC NOTICE OF DRAFT GENERAL PERMIT FOR STORM WATER ASSOCIATED WITH CONSTRUCTION ACTIVITY FROM OIL AND GAS LINEAR TRANSMISSION LINE AND GATHERING LINE INSTALLATION

On the basis of staff review and application of standards and regulations, the Director of the Ohio Environmental Protection Agency will issue a draft general permit for the statewide regulation of storm water associated with construction activity from oil and gas linear transmission line and gathering line installation. The draft permit will be issued as a final action unless the Director revises the draft after consideration of the record of a public hearing or written comments. Any person may submit comments on the draft permit and administrative record.

The General Permit for Storm Water Discharges Associated with Construction Activity from Oil and Gas Linear Transmission Line and Gathering Line Installation (Permit No. OHCG00001) is the first generation of this general permit. This permit would afford coverage to new and existing discharges of storm water from construction activity associated with the installation of oil and gas linear transmission lines and gathering lines throughout the State of Ohio. The permit identifies who can be covered, how an entity obtains coverage, and how a permittee terminates coverage. The permit contains requirements for permittees to develop and implement a Storm Water Pollution Prevention Plan (SWP3) to minimize or eliminate the potential for contamination of storm water from these projects. In addition, a Horizontal Directional Drilling (HDD) Contingency Plan must be developed and incorporated in the SWP3. The HDD Plan must be implemented as a condition of this permit in the event HDD is anticipated for the construction and installation of transmission and gathering lines.

An Ohio EPA public hearing to accept comments on the draft general permit has been scheduled for 3:00 p.m. on May 30, 2018 in Conference Room A at the Ohio EPA Lazarus Government Center, 50 West Town Street, Suite 700, Columbus, OH 43216. The public hearing will end when everyone in attendance has had an opportunity to provide comments related to the draft general permit. In lieu of attending the public hearing, written comments may be submitted as outlined in the following paragraph.

Interested persons are invited to submit written comments on this draft general permit. Comments should be submitted in person or by mail no later than June 6, 2018.
