## Member Directory Update January 2015

The Ohio Interagency Council for Environmental Education (OICEE) was established as part of *Ohio EE 2000*, the statewide strategic plan for environmental education. The OICEE is comprised of state and federal agencies in Ohio that have environmental or environmental education responsibilities. Members are appointed to serve on the council by their agency.

OICEE has four broad objectives:

- To improve communication among and between state and federal agencies by developing mechanisms to facilitate the exchange of information about environmental education-related issues, programs and services.
- To better coordinate and promote environmental education programming, more efficiently utilize and share agency resources, and limit duplication of efforts.
- To more efficiently respond to customer needs for environmental education-related information, programs, services, and technical expertise on best practices that will benefit them at home, in schools, in the workplace and in the community.
- To support implementation of agency environmental education-related missions, policies and programs, and define new opportunities for interagency collaboration.

In addition, OICEE facilitates information exchange between state and federal agencies and the team implementing *Ohio EE 2010*, the current state strategic plan. That plan and the OICEE directory are both hosted on the Environmental Education Council of Ohio Web site, [www.eeco-online.org](http://www.eeco-online.org).

The role of the OAQDA is to provide for the conservation of air as a natural resource of the state and to prevent or abate pollution of the air, to provide for the comfort, health, safety, and general welfare of all citizens of the state and to assist in the financing of air quality facilities for industry, commerce, and research. In addition, the Executive Director serves as Ohio's Small Business Ombudsman, facilitating communications between the small business community and the U.S. EPA. The OAQDA consists of seven members and is served by an Executive Director and staff. Of the seven members, five are public and appointed by the Governor with the advice and consent of the Senate and two serve in an ex-officio capacity, the Director of the Ohio Environmental Protection Agency and the Director of the Ohio Department of Health.

The mission of ODE is to ensure all students reach high levels of academic achievement, a primary key to their success as individuals, workers and citizens. Key objectives include:  
Raise Expectations: Set clear and high expectations for what all students should know and be able to do.

Make sure educators have the skill, knowledge, and resources to help students to achieve higher expectations.

Improve Results: Measure, publicize, and reward results and hold all educators and students responsible for them.

Department activities and services include: developing education standards and monitoring schools for standards compliance; developing and distributing curriculum models; granting school charters and evaluating school performance; distributing state and federal funds for a wide variety of educational programs; granting teacher licenses and managing programs to evaluate teacher performance; as well as other services and activities.

The Department of Education does not directly administer or promote a specific environmental education program, but it does support EE programs managed by other organizations and agencies.

The Regional Professional Development Centers (RPDCs) help to advance the State Board of Education's mission that all students can learn by creating a high performance system of education. The centers are organized to provide long-term,

ongoing, meaningful professional development for all educators and school support personnel. Environmental education organizations and agencies often work with the RPDCs to provide EE professional development at the local level.

### **Environmental Education Programs for K-12 and Higher Education Students and Teachers**

- Health Assessment Section (HAS) produces a variety of **fact sheets**, including *Mercury Spill Fact Sheet for Schools*, as well as fact sheets designed to educate residents concerned about hazardous waste sites and chemicals.
- Indoor Environment Section presents **seminars** for school personnel about indoor air quality using the U.S. EPA Tools for Schools Action Kit. IES also has developed a curriculum involving educational activities in the public schools and other organizations to increase awareness about indoor air quality problems.

### **Environmental Education Resources for the General Public**

- The **Lead Program** provides High Efficiency Particulate Air (HEPA) vacuums for loan to the general public; dispenses information and educational pamphlets

about lead poisoning and its prevention upon request; and conducts training sessions for lead professionals, training providers, landlords, tenants, remodelers, licensed personnel, medical personnel, and the general public.

- HAS **answers questions** from the general public regarding hazardous chemicals in their homes (e.g., mercury recycling as in disposing of thermometers or cleaning up small spills) and researches chemical information for the public when requested.
- Indoor Environment Section **answers questions** related to indoor air quality, including mold and both HAS and IES work with flood hotlines for the public when needed.

The general public benefits from the services noted above in monitoring bathing beaches, water supply, and asbestos removal.

### ***Environmental Education Resources for the Regulated Community***

Several ODH programs provide environmental education/environment-related services to regulated entities. Examples include:

- The **Lead Poisoning Prevention Program** is authorized by U.S. EPA to administer and enforce the lead licensure and approval program in Ohio. This involves licensing lead risk assessors, lead abatement contractors, lead abatement works, lead inspectors and abatement project designers; it approves courses and refresher courses; and approves abatement systems and products, clinical laboratories and environmental lead analytical laboratories.
- The **Asbestos Program** licenses and certifies companies and persons directly involved with the asbestos abatement industry. The program regulates contractors performing asbestos removal projects, project supervisors, project designers, workers removing asbestos, persons inspecting buildings for asbestos containing materials and developing plans to manage asbestos found in a facility, persons conducting air sampling for asbestos and the companies that provide required asbestos training.
- The **Radon Licensing Program** licenses and certifies providers of radon-related services (approximately 1,600 people in a sample year) and provides information.

Private water systems are regulated by the Ohio Department of Health. Private Water Systems are potable water wells, ponds, springs, cisterns and hauled water storage tanks that provide drinking water to fewer than 25 people, less than sixty days out of the year, and have less than 15 service connections. These would include single water supplies that serve homes, small businesses, small churches, small mobile home parks or communities with fewer than 25 residents.

- The Environmental Engineering Section **reviews plans and inspects construction** for all new or substantially altered public swimming pools, spas, manufactured home parks, RV parks and campgrounds, marinas and agricultural labor camps throughout Ohio. The section also **issues flood plain permits** for manufactured home parks that are in a flood plain and provides information and consultation for all of these programs.

### ***Environmental Education Resources for Other Agencies, Organizations and Constituents***

Health Assessment Section evaluates data and provides other agencies, such as Ohio EPA and U.S. EPA with information regarding safe levels of chemicals, potential human exposure, and cleanup levels. HAS evaluates data from ODNR and creates the Ohio Sport Fish Consumption Advisory.

- The **Ohio Childhood Lead Poisoning Prevention Program (OCLPPP)** provides educational outreach and in-services to various healthcare professionals, environmental agencies, and other organizations and disciplines. - The **Pediatric Lead Assessment Network (PLANET)**, under OCLPPP, is a peer-to-peer educational program which brings healthcare professionals some of the most current information available in the field of Childhood Lead Poisoning. PLANET's goal is to provide up-to-date information about Childhood Lead Poisoning and to emphasize the importance of lead screening and patient caregiver education. In a one-hour, lead specific curriculum, PLANET will update healthcare professionals about Ohio's Childhood Lead Poisoning screening recommendations, medical case management, and risk factors. The PLANET program is designed for presentation for healthcare professionals in their offices or other healthcare settings. - The **Bathing Beach Monitoring Program** is a cooperative effort of the Ohio Department of Health, the Department of Natural Resources, local health departments with public beaches within their jurisdictions, and private and public organizations along the Lake Erie border and throughout Ohio. The program samples and analyzes water from selected bathing beaches along the Lake Erie shoreline; analyzes water from various bathing beaches under the control of the Department of Natural Resources throughout Ohio to determine water quality and to monitor changes in the various state park watersheds.
- The Environmental Engineering Program assists local health departments, cities, owners, engineers, architects, and contractors, **reviewing plans and inspecting construction**.

- The **Asbestos Program** works cooperatively with other state agencies, such as Ohio EPA to ensure safety guidelines are met and information is available.



### ***Overall Mission and Organization***

The mission of ODNR is "to ensure a balance between the wise use and protection of our natural resources for the benefit of all." The agency owns or manages more than 590,000 acres of land throughout the state and has jurisdiction over 100,000 acres of inland waters, as well as Ohio's portions of Lake Erie and the Ohio River. In addition to managing these resources for conservation, recreation, and education, ODNR regulates oil, gas and mineral industries in Ohio, manages the state's water resources, coordinates activities of county soil and water conservation districts, and supports local recycling and litter prevention programs. ODNR carries out its responsibilities through the work of 11 divisions:

- **Division of Forestry** manages 20 state forests and provides forest management assistance to private woodland owners in Ohio. It provides assistance to local officials through urban forestry programs and works to prevent the destruction of forest lands by fires, insects and disease.

- **Division of Geological Survey** defines the geologic framework of the state for resource development, property protection, public safety, and environmental security. It conducts geologic mapping, subsurface investigations, remote sensing, and geophysical surveys to produce maps and reports on geologic formations, mineral resources, fossil fuels, coastal processes, and geologic hazards.



## **Overall Mission and Organization**

Ohio EPA's mission is to protect the environment and public health by ensuring compliance with environmental laws and demonstrating leadership in environmental stewardship. The agency has authority to implement laws and regulations regarding air and water quality standards; solid, hazardous and infectious waste disposal standards; water quality planning, supervision of sewage treatment and public drinking water supplies; and cleanup of unregulated hazardous waste sites.

Ohio EPA cooperates with government and private agencies, manages some federally funded pollution control projects, obtains technical and laboratory services, establishes advisory boards, investigates environmental problems, and disseminates information on environmental programs. The director also authorizes enforcement actions against violators of pollution laws and regulations. Ohio EPA's central office is located in Columbus and has seven divisions/offices described below. For additional information, access the division's website or call the number provided.

- **Division of Air Pollution Control (DAPC)** is responsible for meeting the state and federal air quality standards. DAPC has instituted a number of programs that reduce emissions and improve air quality, including industrial controls, restrictions on gasoline stations, and vehicle inspection/maintenance programs (e-check). DAPC and nine local air pollution control agencies monitor air quality throughout Ohio and conduct inspections at the large facilities in the state. Current Ohio air monitoring data are featured in graphs, maps and reports on the division's Web page, [www.epa.ohio.gov/dapc/](http://www.epa.ohio.gov/dapc/). (614) 644-2270
- **Division of Drinking and Ground Waters (DDAGW)** provides technical assistance and educational information on issues such as ground water protection, public water system operation, ground water quality, and proper cleanup of contaminated ground water resources. The Division administers Ohio's Water Supply Revolving Loan Account, Source Water Assessment and Protection Program, Wellhead Protection Program, Operator Certification Program, Compliance Monitoring Program, Ground Water Quality and Characterization Program, and Underground Injection Control Program. The Division has produced a variety of fact sheets, guidance documents, and educational videos that explain the division's programs, applicable regulations, and various ground water and drinking water supply concepts. - **Division of Emergency and Remedial Response.** DERR is focused on environmental clean up and is comprised of 6 programs - Emergency Response (ER), Remedial Response (RR) and the Voluntary Action Program (VAP), Site Assessment and Brownfields Redevelopment, Clean Ohio Fund Program (COF) and Federal Facilities Oversight FFO .The ER program responds to sudden releases of hazardous materials, petroleum and radiation. ER partners with local and state emergency management officials to minimize and prevent releases to the environment. The RR program determines whether or not potentially contaminated sites represent a risk to human health or the environment and whether they are safe for their intended use. In cases where a clean up is necessary, the RR program oversees the cleanup. SABR provides outreach to communities dealing with blighted and contaminated properties, raising awareness of the available sources of technical and financial assistance for the revitalization of brownfields, including the Clean Ohio Revitalization Fund. The VAP allows companies to investigate possible environmental contamination, clean it up if necessary and receive a promise from the State of Ohio that no more cleanup is needed. The VAP minimizes governmental red-tape and maximizes resources and expertise in the private sector. Anyone can undertake a cleanup project and, by following the VAP cleanup rules, be assured it meets environmental standards without direct oversight from Ohio EPA. And the FFO oversees the investigation and remediation activities at federal cleanup sites in Ohio. The section provides cleanup oversight and facilitates environmental monitoring, emergency response, remedial actions and public outreach at Department of Energy (DOE) and Department of Defense (DoD) sites in the state. - **Division of Hazardous Waste Management (DHWM)** offers many services to help the general public and the regulated community understand Ohio's hazardous waste laws and cessation of regulated operations laws. These services include:

  - Workshops (e.g., Ohio's hazardous waste regulations, management of fluorescent lamps in Ohio, pollution prevention options for automotive repair facilities)

- **Division of Solid and Infectious Waste Management (DSIWM)** is charged with: encouraging waste reduction and recycling statewide; overseeing local solid waste planning efforts; regulating solid waste landfill, composting, incinerator, and transfer facilities; regulating the generation, transportation, and treatment of infectious waste; regulating construction and demolition debris landfills; and regulating the transportation, collection, storage, disposal, beneficial use, and recovery of scrap tires. DSIWM also oversees state-funded scrap tire cleanup efforts. Fact sheets and guidance documents on a variety of topics are available on the DSIWM Web page, [www.epa.ohio.gov/dsiwm/](http://www.epa.ohio.gov/dsiwm/). DSIWM staff members are available to answer questions and make presentations to interested audiences. - **Division of Surface Water (DSW)** distributes a number of reports, publications and fact sheets describing water quality conditions in Ohio, and explaining Ohio EPA's activities to protect the state's lakes, rivers, and streams. The Division provides technical assistance to operators of wastewater treatment facilities, to builders and municipalities on storm water runoff, to anyone requesting information on wetlands, dredging and filling operations, and many other issues. The Division performs demonstrations for schools and other interested groups, showing how Ohio EPA uses bugs, fish and other organisms to monitor water quality. - To manage the agency's programs at the local level, the state is served by five **district offices**. There are six divisions in each district office: air pollution control, surface water, drinking and ground water, solid and infectious waste management, hazardous waste management, and emergency and remedial response. District personnel review permit applications, inspect facilities, identify environmental violations, oversee some cleanup projects, provide technical assistance to municipalities and industry, assess air and water quality conditions, and manage the agency's pollution control programs at the local level. Contact with the public is one of the main responsibilities of the district offices. District office staff members are available on a limited basis for classroom presentations, science days, land labs, career days, Earth Day events, and other environmentally related outreach activities. - **Ohio Environmental Education Fund (OEEF)** provides mini grants of \$500 - \$5,000 and general grants of up to \$50,000 for environmental education projects targeting pre-school through university students and teachers. Application deadlines are January 15 and July 15 each year, and grants are awarded through a competitive, peer reviewed process. Grant recipients must be Ohio-based organizations, and include schools and universities, state and local government agencies, private companies, and non-profit organizations. The OEEF Web site [www.epa.ohio.gov/oeeef/Home.aspx](http://www.epa.ohio.gov/oeeef/Home.aspx) provides examples of funded projects, including school stream sampling programs, development of outdoor classrooms, and hands-on activities illustrating energy production and conservation. K-12 proposals must show how student activities align with the Ohio Department of Education's Academic Content Standards for the appropriate discipline. OEEF also offers scholarships for college students in environmental science and engineering, described in the pages that follow.
- **Ohio Clean Diesel School Bus Fund** provides Ohio school districts with grants up to \$300,000 to retrofit school buses with pollution control equipment, to improve air quality and reduce student and driver exposure to the pollutants in diesel exhaust. Application deadlines are March 1 and September 1 each year, with application information online at [www.epa.ohio.gov/oeeef/schoolbus.aspx](http://www.epa.ohio.gov/oeeef/schoolbus.aspx)
- **Professional Development for Educators:** The Office of Environmental Education partners with the Environmental Education Council of Ohio (EECO) to provide professional development opportunities to teachers and non-formal environmental educators who work with the pre-school through university audience. This partnership distributes education materials through a network of more than 2000 school contacts, regional directors coordinating workshops in each of Ohio's 12 education regions, curriculum resources, and a guide to the

development of school land labs. Each year, the partnership supports one statewide and three regional conferences, and offers more than 60 local workshops serving between 1,200 and 1,500 educators statewide. Many of these workshops are in nationally recognized EE curricula such as Project WET, Project WILD, Project Learning Tree, the Leopold Education Project, and Project Food, Land and People. Recently funded projects focused on preventing storm water pollution; protecting local watersheds, wetlands and vernal pools; encouraging energy conservation and recycling; protecting native species; disposing of mercury thermometers and sharps safely; fish consumption advisories; and steps homeowners can take to maintain septic systems.

Recently funded projects focused on energy and fuel efficiency for businesses and fleet managers; management of pharmaceutical wastes; storm water management tools for developers; pollution prevention for hospitals; compliance assistance for automotive repair businesses and compost facilities; and best management practices for farmers and livestock producers. Other OEEF-funded seminars have focused on petroleum releases and spills, office waste reduction, and operation of small wastewater treatment systems.
- **Office of Compliance Assistance and Pollution Prevention (OCAPP)** provides technical assistance to companies, organizations and individuals on techniques to prevent or minimize the creation of pollution. Services include a toll-free hotline, on-site compliance and P2 assessments, workshops and training, a library of publications that explain requirements and P2 opportunities in plain English, a quarterly newsletter, and assistance in completing air permit application forms. Specific initiatives include a Brownfield Focus Group Environmental Insurance Program; programs for communities with municipal separate storm sewer systems (MS4s); Ohio's Food Scrap Management Initiative; Ohio's Tox-Minus Initiative asking 100 of the top Toxic Release Inventory reporters for 2005 to implement effective pollution prevention strategies to reduce waste, air and water-related TRI emissions. Other initiatives include the Governor's Awards for Outstanding Achievement in Environmental Stewardship, and mercury reduction efforts, such as the Ohio Voluntary Mercury Switch Removal Program for auto recyclers. - **Environmental Science and Engineering Scholarships:** The Ohio Environmental Education Fund (OEEF) in the Office of Environmental Education partners with the Ohio Academy of Science to offer merit-based scholarships to environmental science and engineering students at state-supported two-year and four-year colleges and universities. The program seeks to promote the professions of environmental science and engineering, and to provide incentives and career motivation in environmental protection. Each year scholarships up to \$2,500 are awarded to fourth and fifth year students at universities, and scholarships up to \$1,250 are awarded to second year students at technical and community colleges. - Ohio EPA supports three specific initiatives to interest younger Ohio students in careers in environmental science and engineering. The Ohio Environmental Education Fund is a major sponsor of **State Science Day**, the state championship competition for middle and high school student science research projects coordinated by the Ohio Academy of Science. Activities include judging and presenting the Governor's Awards for Excellence in Environmental Protection Research to 24 of the best environmental science projects by 7<sup>th</sup> through 12<sup>th</sup> grade students from across Ohio. The **Floating Classroom Pilot Program** is an Ohio River-based experience designed to educate 10<sup>th</sup> and 11<sup>th</sup> graders about water quality issues, including water monitoring, watersheds, land use, navigation, and water pollution. The program will teach students how to collect and analyze data, and to combine these skills with critical thinking to solve water quality issues in their community. The program will also enhance environmental education programs within the Ohio River basin by providing professional development for teachers, and by connecting students and teachers to regional organizations that will help them develop community action projects.

The focal point of the program is a four-hour interactive voyage aboard the ORSANCO River Education Center (OREC), a historic sternwheel boat that is being renovated to include five learning stations. At these stations, students will use scientific equipment to observe the river area, to collect chemical and biological data, to learn about river history and navigation, and to solve a simulated pollution problem.



**Maritime Safety:** The Coast Guard is renowned throughout the world as "America's Lifesavers;" prevention, founded on expert risk assessments to reduce the probability of mishaps, will be the watchword of the future, and advanced technologies will continue to be embraced to increase the success of maritime safety and security measures.

**Maritime Mobility:** Charged with ensuring a safe, efficient, and effective marine transportation system, the Coast Guard regulates and inspects commercial and private vessels, licenses merchant mariners, manages waterways, and protects the security of America's ports. Our Aids to Navigation Program and Vessel Traffic Services help to ensure safe vessel movements.

**Maritime Security:** We are the only Federal law enforcement agency with jurisdiction in both U.S. waters and on the high seas for the enforcement of U.S. laws and treaties.

The U.S. Exclusive Economic Zone holds some 20 percent of the world's fishery resources and supports a commercial industry valued at more than \$25 billion. The Coast Guard's boarding and inspections of both foreign- and U.S.- flagged fishing vessels have increased significantly in recent years and are critically important factors in helping to rebuild and maintain fish stocks at risk from over fishing.

***National Defense:*** We maintain a high state of readiness to function as a specialized service within the Navy and have command responsibilities for the U.S. Maritime Defense Zones. Moreover, its operational capabilities figure importantly in small-scale contingencies, humanitarian assistance efforts, maritime interdiction operations in support

of United Nations sanctions, and port security in overseas theaters, as well as in other important military-operations-other-than-war (MOOTW) missions.

The US Coast Guard will offer unique, non-redundant, and complementary military capabilities to America's national defense needs.

***Protection of Natural Resources:*** The Coast Guard's prevention, enforcement, and response tasks in marine environmental protection help to reduce the amount of pollution entering America's and the world's waterways. Coastal tourism and marine recreation demand clean shorelines and marine environments. The Coast Guard's prevention of oil spills from all sources and activities saves nearly \$6 billion each year in oil losses, cleanup costs, and environmental damage. When prevention and enforcement fail, however, the Coast Guard maintains a rapid response capability to contain and recover from pollution incidents. Three well-trained and well-equipped Coast Guard National Strike Teams – located on the East, Gulf, and West coasts – are at the ready to respond to major oil or other hazardous material spills in the inland waterways and coastal regions.


